Introduction

Subject of information note

In these web pages our company uses technology that resorts to the so-called "cookies". This informative note fulfils the purpose of explaining to users how to use cookies in a clear and precise manner. This document cancels and fully replaces any previous indications on cookies given by the company, which shall be deemed as completely superseded.

What are cookies?

Cookies are strings of text (small text files) which the websites visited by a user send to his/her terminal (PC, tablet, smart phone, etc.), which stores them and then returns them to the websites from which they were originally sent at the time of the next visit by the user.

Types of cookies and purposes

The cookies used in this website belong to the following types.

- Technical Cookies: they enable the user to navigate the website in an optimised and fast manner, and to efficiently use
 the services and/or the various options that the website offers, for instance, to make a purchase or to log in to reserved
 access areas. These cookies are used to enhance website usability, but they may be disabled.
- 2. Analysis cookies: these are anonymous and aggregated web analysis tools that provide information on how users utilise the website, how they reached the website, the number of visits and their duration, etc. These cookies help to introduce improvements to the website for easier access by users, and to process statistical data. As these cookies are not necessary for optimised usability of the website, they can be disabled.
- 3. **Third-party cookies:** these cookies are placed on a user terminal by third party website providers through the website that the user is visiting. Third-party cookies, which mainly have analysis purposes, are in most cases generated by Google Analytics functions. To disable cookies and to prevent Google Analytics from collecting browsing data, the user can download an additional browser component for the de-activation of Google Analytics from the following link: https://tools.google.com/dlpage/gaoptout.

Browser setting

The user can also configure, freely and at any time, his/her privacy parameters relating to the installation and use of cookies directly through his/her browser, following the relevant instructions.

More specifically, the user can set the so-called "private browsing" function which causes the user's browser to stop saving the history of visited websites, any entered password, cookies and other information relating to the visited pages.

Please note that, where the user decides to disable all cookies (including technical cookies), the quality and quickness of the services offered by this website may dramatically worsen, and access may be denied to some sections of the website.

Practical user guidance for correct browser setting

The simple instructions given below, which apply to the most common browsers, may be referenced to either block or restrict the use of cookies by both this website and other websites, using your browser directly.

Google Chrome: click the icon "Customize and control Google Chrome" on the top right-hand side of the page. Then select the menu item called "Settings". A screen opens where the menu item called "Show advanced settings" can be selected. Under the "Privacy" menu item click the "Content Settings" button where it is possible to block all the cookies or a part of them.

Microsoft Internet Explorer: click the icon "Tools" on the top right-hand side of the page and then select the menu item called "Internet options". A screen opens: select the menu item called "Privacy" where it is possible to set whether to block all the cookies or a part of them.

Mozilla Firefox: select the menu item "Options" from the drop-down menu at the top left-hand side of the page. A screen opens: select the menu item "Privacy" where it is possible to set whether to block all the cookies or a part of them.
