

## **Cookies policy**

### **1. Premises.**

**1.1.** This information was drawn up for this website [www.coopselios.com](http://www.coopselios.com) (hereinafter only "Site") based on Provision n. 229 of 8.5.2014 signed by Italian Supervisory Authority (entitled "Identification of the simplified procedures for the information and the acquisition of consent for use of cookies"), then clarified with a Circular dated 4.6.2014 signed by same Authority (entitled "Internet: Privacy Authority, no to cookies for profiling without consent") as well as on basis of subsequent european and national legislation in force on this subject.

**1.2.** This information is therefore intended to provide the user who navigates the Site with detailed information about the types and purposes of use of cookies on Site.

### **2. Definition and types of cookies.**

**2.1.** Cookies are small text strings that the site visited by the user sends to his/her terminal (usually the browser), where are stored before being transmitted to the same site on the next visit by the same user.

**2.2.** The cookies used on the Site consist of following types:

- I. **Technical cookies:** technical cookies are those used for sole purpose of "carrying out the transmission of a communication over an electronic communications network, or to extent strictly necessary for the provider of an information society service explicitly requested by the contractor or by the user to provide this service" (see art. 122 of revised Legislative Decree n. 196/2003); they can be divided into navigation or session cookies, which guarantee the normal navigation and use of website, or into functionality cookies, which allow the user to navigate according to a series of selected criteria in order to improve the service rendered to same.
- II. **Analytical cookies:** they are used to collect information, in aggregate and anonymous form, on number of users and how they visit the site.
- III. **Third-party cookies:** they are set by a website other than the one the user is visiting; while browsing the site, the user can also receive cookies on his/her device that are sent to interact directly with the social platforms, using buttons and/or widgets: the interactions and information acquired through these tools are, in any case, subject to the user's privacy settings relating to each social network.

The types of cookies described above do not require the prior consent of the user, in compliance with the provisions of aforementioned Provision n. 229/2014 signed by Privacy Authority.

**2.3.** Finally it should be noted that profiling cookies have not been installed within Site, i.e. those cookies aimed at creating profiles relating to the user, in order to send advertising messages in line with preferences expressed by the same in context of browsing network.

### **3. Browser settings.**

**3.1.** We also inform you that the user can configure - freely and at any time - their privacy parameters in relation to installation and use of cookies directly through their navigation program (browser) by following the relative instructions. In particular, user can set the cd. private browsing, thanks to which your browsing program stops saving the history of websites visited, any passwords entered, cookies and other information on the pages visited.

**3.2.** Finally, we warn that in event that the user decides to disable all cookies (including those of a technical nature), the quality and speed of the services offered by Site could drastically deteriorate and could lost access to some sections of Site itself.

### **4. Information on Controller (and Joint Controller) and on Data Protection Officer.**

**4.3.** The user can exercise rights provided for in articles from 15 to 22 of GDPR using the contact details described above.

**4.4.** Finally, in compliance with Guidelines n. 7/2020 and 8/2020 signed by European Data Protection Board and in compliance with sentence of Court of Justice of UE dated 29.7.2019 (case C-40/17; so-called sentence "Fashion ID"), COOPSELIOS announces that the presence, within Site, of one (or more) social plug-ins (e.g. Youtube; LinkedIn) determines the existence of a joint-controlling pursuant to art. 26 of GDPR between COOPSELIOS and the related social network service (or similar) limited to collection and communication activity, by transmission, of personal data of Site's visitors to related social network (or similar), with express exclusion, therefore, of subsequent processing operations of visitor's personal data carried out by relative social network (or similar) following transmission of such information to latter by COOPSELIOS (through Site).
